The Chisago County Board of Commissioners met in regular session at 6:30 p.m. on Wednesday, April 04, 2018 at the Chisago County Government Center with the following Commissioners present: Greene, McMahan, Montzka, Robinson. Also present: County Attorney Janet Reiter, County Administrator Bruce Messelt, and Clerk of the Board Chase Burnham.

The Chair called the meeting to order and led the assembly in the Pledge of Allegiance.
