Actual Results	<p>In 2018, the Code Enforcement Officer spent approximately 200 hours on Wetland Conservation Act-related activities pertaining to subdivisions, gravel pits and solar garden permit applications. The Water Resource Manager assists the wetland specialist by submitting the block grant application and report. The Wetland Specialist convened and conducted monthly technical evaluation meetings.</p> <p>The Wetland Specialist enforced and/or resolved wetland violations and several potential wetland violations resulting in lengthy monitoring of wetland restoration orders. In 2018, the wetland specialist evaluated several pond applications, all of which required site visits and permits issued. The wetland specialist issues and monitors the shoreland grade and fill permits and comments on most of the DNR public water permits. The wetland specialist serves as the Chisago County Agricultural, Weed and Ditch Inspector.</p> <p>Chisago County experienced several more solar garden and subdivision applications and all of which required wetland delineation reports. The wetland specialist is responsible for ground truthing and approving each one of these delineations. 2018 also saw development and housing starts increase to numbers typical of the pre-recession years. As such delineation permitting has increased in that arena as well.</p> <p>The wetland specialist continues to oversee the maintenance of the Chisago County public and private ditch and drainage system for functionality and adherence to the drainage code and the Wetland Conservation Act drainage standards.</p> <p>The Wetland Specialist continued to work with the Chisago Lakes Lake Improvement District, the Comfort Lake Watershed District, the county attorney and the DNR to facilitate the necessary permitting to maintain drainage and pursue water quality projects within the system.</p>

Actual Results	<p>\$5,000 transferred to Chisago SWCD to assist with Wetland Conservation Act programs in Chisago County. Assistance includes working with landowners who have a WCA violation to bring them into compliance, assisting with wetland delineation reviews, providing guidance to landowners with general WCA rule questions, attending WCA TEP meetings, and providing assistance to consultants, landowners, and county staff when County Wetland Specialist Jeff Fertig is out of the office on leave. As of October 31, 2018, \$7,708 in Chisago SWCD staff time assisting with the wetland conservation act programs in Chisago County.</p>
